

**Watson town Borough  
Council Meeting  
April 9, 2018**

**OPENING:** The April 9, 2018 Watson town Borough Council Meeting was called to Order by Council President Greg Miller at 7:00 pm. The meeting was held in Council Chambers, 318 Main Street, Watson town. The opening prayer was given by Mayor Russ McClintock, followed by the Pledge of Allegiance to the American Flag.

**MEMBERS PRESENT:** Members present were President Greg Miller, Vice President Ken Hollenbach, Dan Folk, Todd Moyer, Brent Frey, Harry Hefty, Mayor Russ McClintock, Solicitor John DeWald, Chief of Police Rodney Witherite, Borough Manager Jay Jarrett and Secretary/Treasurer Brendi Brooke.

**OTHERS PRESENT:** Vera Young, Ralph Young, Virginia Wirth and Crystal Moyer.

**APPROVAL of MINUTES:** A motion was made by Ken Hollenbach, seconded by Dan Folk to approve the minutes from the March 12, 2018 Council Meeting and the March 26, 2018 Committee Workshop. A roll call vote was taken as follows:

**BILLS & TRANSFERS:** After a lengthy discussion regarding the invoices from Light-Heigel – receipts versus fees charged to the Borough, etc.; Jay said he will have additional information regarding Council’s concerns at the Committee Workshop. A motion was made by Harry Hefty, seconded by Ken Hollenbach to approve the bills and transfers for April 2018 in the amount of \$263,873.04. A roll call vote was taken as follows:

**CEMETERY:** Todd Moyer said the cemetery wall has been repaired.

**AMENDED RENTAL ORDINANCE 2018-01:** Jay said the rental ordinance was amended to reflect the following changes:

**\* rental inspections are now required every 2 years or upon a change in tenants instead of every 4 years**

**\*upon a change in tenants within the first 12 months after a successful inspection, no re-inspection is required**

Harry Hefty made a motion, seconded by Dan Folk approving Rental Ordinance 2018-01, as amended. A roll call vote was taken as follows:

**PURCHASE NEW  
DUMP TRUCK:**

After a brief discussion, a motion was made by Dan Folk, seconded by Ken Hollenbach to purchase the new DPW dump truck, not to exceed \$70,000.00. Jay said approx. \$48,000.00 had been budgeted for a new pick-up truck; they will make up the difference in other areas. The worst case scenario would be to transfer the difference from the Capital Reserve Fund if Public Works runs short. The dump truck will be a more useful piece of equipment as it can be used year round. A roll call vote was taken as follows:

Brent Frey asked about adding additional work; Jay said depending on the cost of the bids, we could put additional work out to bid, later this year. Jay confirmed there is a list that Council continues to work from; other projects get added as time passes. Jay said he will provide the list and prices to Brent for review. Dan Folk made a motion to advertise the 2018 paving bid, seconded by Todd Moyer. A roll call vote was taken as follows:

Others mentioned the locking of the gate at the 8<sup>th</sup> Street Park and locking doors at the pool house restroom – neither are done anymore. Jay spoke to the concerns with the restrooms.
