

**Watson town Borough  
Council Meeting  
September 25, 2017**

**OPENING:** The September 25, 2017 Watson town Borough combined Council Meeting/Committee Workshop was called to order by President Janet Rump at 7:00 pm. The meeting was held in Council Chambers at the Borough Building, 318 Main Street. The opening prayer was given by Mayor David Hontz, followed by the Pledge of Allegiance to the American Flag.

**MEMBERS PRESENT:** Members present were President Janet Rump, Vice President Harry Hefty, Ken Hollenbach, Greg Miller, Dan Folk, Mayor David Hontz, Solicitor Tom Marshall, Chief of Police Rodney Witherite, Borough Manager Jay Jarrett and Secretary/Treasurer Brendi Brooke. Joshua Fogelman was absent.

- THANK YOU:** A thank you was received by the Milton’s First Presbyterian Church for the advertising of their Faith in Action Block Party in the Borough’s newsletter.
- COMBINED MEETING:** President Rump reminded everyone that tonight is Council Meeting and Committee Workshop combined due to a lack of a quorum on September 11, 2017.

- FINANCE:** 2018 Budget – Meeting dates have been set per Harry Hefty.
- CEMETERY:** Ken Hollenbach said the committee will continue to work towards repair of the cemetery fence.
- ELECTRIC:** Harry Hefty spoke of the electric contact resolution on tonight’s agenda.

- PARKS & RECREATION:** Ken Hollenbach spoke of the pot hole that was fixed by the Borough crew. The Public Works Department was thanked by many in attendance for their excellent job at clearing of the riverbank.

- PROTECTION TO PERSONS & PROPERTY:** Jay said he spoke with Northumberland County EMA and they are trying to get us another “plastic chart” to replace the flood stage chart on the river bridge pier.
- STREETS & HIGHWAYS:** Dan Folk said the paving is done; Jay will be reviewing a punch list with Mid-State Paving before they are paid.

**WATERCRAFT:** Chief Witherite asked the Borough to consider getting with the Fire Department to acquire possible watercraft.
